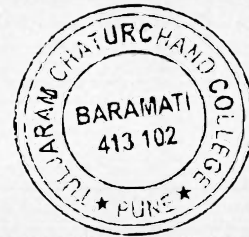

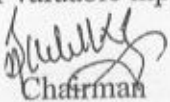
Board of Studies Meeting
