The meeting took place in online mode, Mrs. Sudha Patil chairman of BoS of BBA (C.A) called the ZOOM meeting on Sunday, 10<sup>th</sup> May, 2020 at 11.00 a.m. She introduced and welcomed all members of Board of Studies and taken review on last meeting.

**1. To confirm the minutes of the BOS meeting held on 5<sup>th</sup> April, 2019.**

Mrs. Sudha Patil read the minutes of the BOS meeting held on 5<sup>th</sup> April 2019 and put forward to the BOS members for the approval.

**2. To prepare and approve curriculum of SYBBA (C.A) Semester-III and Semester IV (2019 pattern) to be implemented from the academic year 2020-2021.**

The Board of Studies (BOS) members meticulously designed and crafted the curriculum for Semester III and Semester IV of the SYBBA (C.A) (2019 pattern) program well in advance of the BOS meeting. This preliminary draft was then shared with all BOS members for their input and suggestions to enhance its quality.

All the present members were discussed the syllabus of S.Y.BBA (C.A) and gave suggestions on the designed syllabus. All subjects of Semester III and Semester IV were discussed in the meeting and all the members gave their suggestions as per current industry need.

Mr. Harish Saitwal, Mr. Anand Mehta suggested to add web services to the syllabus subjects Web Technologies and Advanced Java programming.

In addition, Dr. Sagar Jambhorkar recommended adding R-programming to the Business Statistics course and including real-world application in the lab course for networking equipment such as hubs, switch routers, etc.

Dr. Amol Goje sir gave suggestions in networking like to add practical oriented assignment on Wireshark, Putty, Telnet etc. Also, he suggested that add some Extra Reading concept to each subject.

Dr. Santosh Chowhan suggested some modification to Python Programming like to add some case studies in Python programming. At the end Mr.Mehta suggested to add some Networking based courses as certificate courses like CCNA.

In light of the constructive suggestions offered by the BOS members, the curriculum structure underwent necessary revisions. After thorough deliberation and careful consideration, the curriculum of following courses was presented for approval during the BOS meeting.

**Resolution No. 3:** Considered and Approved


**4. Any other matter with the consent of Chairperson.**
