

C. College, and Baramati. The meeting took place online mode, adhering to the guidelines and protocols set by the college. Under the guidance of Mr. Devidas V. Bhosale, Chairman of the Board of Studies in Defence and Strategic Studies, the meeting commenced with a warm welcome to all the esteemed members, followed by a brief introduction of the meeting's objectives.

During the meeting, fruitful discussions were held on the items mentioned in the circulated agenda. We are pleased to inform you that the following resolutions were made during the BOS meeting.

Mr. Devidas V. Bhosale read the minutes of the BOS meeting held on 14th March 2020 and put forward to the BOS members for the approval.

Brigadier Hemant Mahajan recommended the inclusion of a new topic focusing on the warfare and strategy and their implications in the course DEF-3501(B). Dr. Devendra Vispute suggest Incorporating some methods of warfare according to the changing concepts of warfare with time in the same course. Prof. Adinath Londhe requested the inclusion of the inclusion of newly emerging organizations in the DEF-3502 course.

Resolution No. 5: Considered and Approved


