MINUTES OF THE MEETING

As per the notice issued by the college, the meeting of Board of Studies in BBA(C.A) was successfully held on 22th December, 2021 at 11:30 am. The meeting took place in online mode adhering to the guidelines and protocols set by the college under the guidance of Chairman of the Board of Studies in BBA(C.A), the meeting commenced with a warm welcome to all the esteemed members, followed by a brief introduction of the meeting's objectives by Mrs.Rupali Babar.

During the meeting, fruitful discussions were held on the items mentioned in the circulated agenda. We are pleased to inform you that the following resolutions were made during the BOS meeting.

1. To confirm the minutes of the BOS meeting held on 26th April, 2021.

Mrs.Sudha Patil read the minutes of the BOS meeting held on 26th April 2021 and put forward to the BOS members for the approval.

Resolution No. 1: The minutes of the previous Board of Studies meeting were approved and confirmed.

2. To Review the syllabus of TYBBA (C.A) Semester-VI (2019 pattern) to be implemented from the academic year 2021-2022.

The Board of Studies (BOS) members meticulously designed and crafted the curriculum for Semester VI of the TYBBA(C.A) program well in advance of the BOS meeting. This preliminary draft was then shared with all BOS members for their input and suggestions to enhance its quality. The present members were discussed on structure and syllabus of TYBBA (C.A) Semester VI and gave suggestions on the syllabus.

Sir also suggested that arrange professional workshops on different concepts of Big Data that was not covered in the syllabus.

Dr. Santosh Chowhan suggested to introduce case studies in Data Analytics subject and conducting those case studies through practical.

Members discussed and come to the conclusion that slight modifications is needed in the syllabus of Sem VI paper, Data Analytics (BCA3601).

Mr.Anand Mehta suggested to introduce Android IOs in Android Application Programming paper of TYBBA(C.A.) Semester V or arrange expert's workshop on it to provide knowledge to students.

In light of the constructive suggestions offered by the BOS members, the curriculum structure underwent necessary revisions. After thorough deliberation and careful consideration, the curriculum of following courses was presented for approval during the BOS meeting.
