3. To know KYC procedure (Opening of Trading and Demat Account)

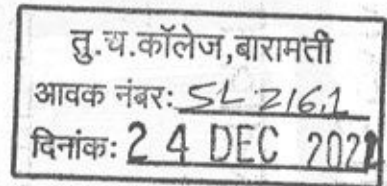

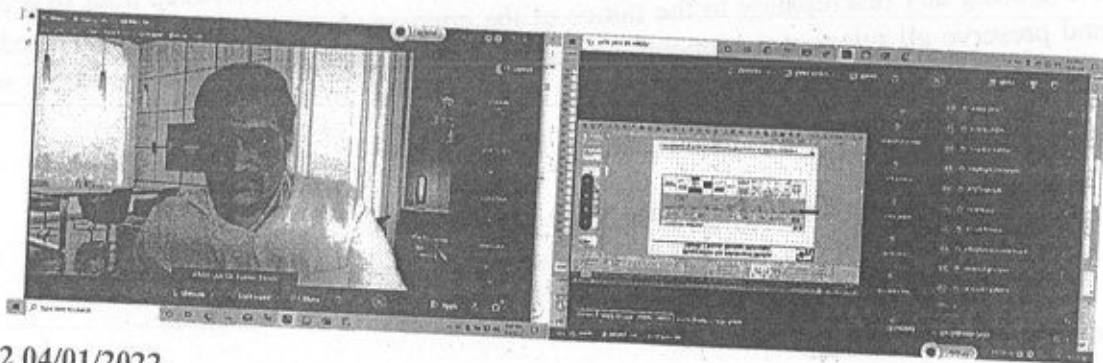
## Report on Five Day National Webinar on "Investment in Share Market"

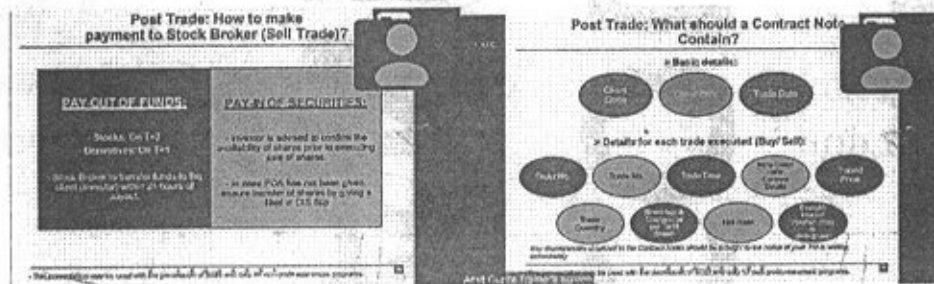
### Day 3 05/01/2022
