# Memorandum of Understanding

between

## Tuljaram Chaturchand College

## of Arts, Science & Commerce, Baramati.

and

# Paul Hebert Centre for DNA Barcoding & Biodiversity Studies, Dr. Babasaheb Ambedkar Marathwada University, Aurangabad.

This Agreement made and entered into on this day of 05th April 2022 between Tuljaram Chaturchand College of Arts, Science & Commerce, an autonomous academic institute situated at Baramati (413102) and Paul Hebert Centre for DNA Barcoding & Biodiversity Studies, Dr. Babasaheb Ambedkar Marathwada University, Aurangabad.

## **Objectives of MoU:**

- 1. Joint research projects / works in the area of molecular systematics, genomics and process development.
- 2. Exchange of teachers/students for training for short durations.
- 3. To conduct joint trainings/workshops/conferences in the area of mutual interests.

### Terms & Conditions of MoU:

- This MoU will be valid for three years commencing from 05<sup>th</sup> April 2022.
- 2. Use of laboratory facilities for specific educational programmes.
- 3. To conduct research activities by the faculties & students of both institutes.
- 4. Resultant outcome will be published with mutual authorship with priority for first
- author from researcher's side. 5. Generated IPR will also have mutual authorship and rights.
- 6. There will be no financial obligations on both the parties.

## DETAILS OF FIELD OF COOPERATION/COLLABORATION:

- a. Both the institutions shall evolve a mutually acceptable schedule to develop educational programs, curriculum design, content creation, and admission, conduct of courses, sharing infrastructure, hold seminars and exchange visits.
- b. The said academic interaction and intellectual assimilation may include. i. Faculty/staff development and exchange.
  - ii. Exchange of students.
  - ii. Organising seminars, research programmes, conferences and workshops, etc.
  - iv. Field work, hands on training, skill development and placement of students.

#### **EXCHANGE OF STUDENTS/TEACHERS/OFFICERS**

- a. Reciprocal arrangements based on mutually acceptable terms shall be accomplished to give an impetus to collaborative training programmers & research.
- b. Teachers, researchers, Officers, and students of both the organizations shall be encouraged to work in tandem in the plant, laboratories, workshops, faculties and departments of both the organizations.

c. Issues relating to travel, boarding, lodging, miscellaneous expenses shall be incorporated in this Para and shall vary according to the rules, regulations and policies of respective organization chaturcha

## MISCELLLANEOUS

- a. The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the organizations.
- b. The parties to this memorandum may, by mutual consent add, modify, amend, delete, review or revise any term(s) and condition(s) of this agreement.
- c. The intent and implementation of this memorandum is SUBJECT to the policies of the respective states (in case of international agreements) and the laws of the land.

#### CONFIDENTIALITY

- a. The parties to this MoU undertake to treat as CONFIDENTIAL AND PRIVILEGED information of the other organization, which is so classified in advance.
- b. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.
- c. After the completion of the research work, both organizations may go for publication/patent as per the following.
  - i) Authority to present/publish research paper as per the joint authorship.
  - ii) Right to Patent by shared expenses as well as benefits.

#### NON-EXCLUSIVITY

- a. The relationship of the parties under this MoU shall be non-exclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind.
- b. However, when entering into a particular research agreement, the participants may agree to limit each party's right to collaborate with others on that subject.

#### TERMS AND TERMINATION

This MoU, unless extended by mutual written agreement of the involved parties, shall expire three years after the effective date specified in the opening paragraph. This MoU may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MoU upon 60 days prior written notice to the other party.

#### RELATIONSHIP

Nothing in this MoU shall be construed to make either party a partner, an agent or legal representative of the other for any purpose.

It is understood by the Parties herein this MoU is based on the professional competence and expertise of each party and hence neither party shall transfer or assign this agreement, or rights or obligations arising hereunder, either wholly or in part, to any third party.

This MoU is executed in duplicate with each copy being an official version of the Agreement and having equal legal validity.
