Subject: Report of Study Tour of F.Y.B.Sc., S.Y.B.Sc., T. Y. B.Sc. Environmental Science

Respected Sir,

With reference to above subject and with your prior permission and sanction we have organized two days study tour of **F.Y.B.Sc., S.Y.B.Sc., T.Y.B.Sc. Environmental Science** students to Mahabaleshwar - Revdand, Revdand - Mumbai Waste Management Ltd for day 1 and 2 respectively. 27 students (9 boys and 18 girls) along with two teaching staff viz. Ms.S.S.Sonawane, Mr. A.D.More and two research students Arati Shevate and Ganesh Pawar and one non-teaching staff Mr. Ganesh Gatkal was participated in the tour.

In the morning at 5.30 am, we started our journey from our college campus towards, Pachgani - Mahabaleshwar via Nira, Vathar, Vai and reached at 9.30 am. We reached at Pure Berry's Industry, Panchgani, where Ashwini Dhanawade mam and Swapnali Vande mam gives us information about how cheese and jelly produced in the industry. After that we travelled to Mahabaleshwar.

We reached 11:20 a.m. at a Biodiversity Park, Mahabaleshwar; there was different plant species. Some of them were endemic to that place. There was some orchid observed viz *Dandrobium nanum*. Medicinally important plants like *Terminalia alato*, *Terminalia chebula*, *Allophylus cobbe*, *Butea monopserma*, *Clerodendrum multiflorum*, *Emlica officinalis*, *Terminalia Bellirica* etc. The different wild species of bamboos are observed. From Biodiversity Park, we left at 1.20 pm, had lunch and proceeded to Revdanda.

We reached at Revdanda at 5.45 pm and enjoyed sunset at beach for while. Accommodation were arranged at Vedant Cottage. At morning, we see Revdanda fort and costal ecosystem and take breakfast at 9.30 am. We left that place at 10.30 am and travelled toward Taloja.

We reached at Mumbai Waste Management Ltd. At 2.15 am. After the all documentation we were allowed to enter the company. In that company, Mr. Omkar Kulkarni sir show us presentation on solid waste management and processes while treating waste provided by other
