



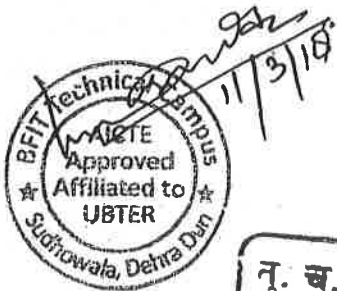

**4. Performance:**

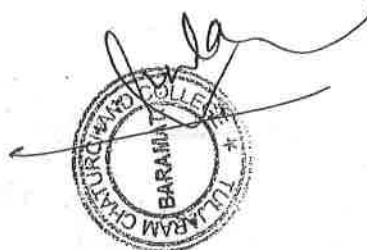
Both the parties undertake to perform the services with the highest standards of professional and ethical competence and integrity.
