1. AGREEMENT

2. BACKGROUND

- Whereas the TC has the supporting facilities, human resources in terms of faculties and 2.1. students desirous of undertaking teaching, research, development, and extension programs in the disciplines of Electronics is desirous of undertaking collaborative work with Ai adventures and provide facilities and resources for Programming in Python and AI.
- 2.2. Whereas AA has the expertise in the Python, Machine Learning in the field of Software in Electronics...
- 2.3. Faculties from TC and engineers from AA had meetings to discuss the common collaborative work to benefit the students and society complementing each other's work. Consequently, it was decided to have an MOU as a tool to facilitate joint efforts to achieve objectives of mutual interests of TC and AA.

3. SCOPE OF THE AGREEMENT

- Specific Activities: Specific activities and programs implemented under the authority of this 3.2. MOU and as decided from time to time on the topics of mutual interest of Department of Electronics of TC and AA shall be subject to availability of funds and the approval of institution's authorized representatives. The institutions contemplate implementation of programs or activities such as:
 - (a) joint educational and training activities
 - (b) exchange of expertise, graduate, postgraduate students for lectures, and discussions
 - (c) exchange of academic materials and other information
 - (d) special, short- term training programs and

STUDENTS TRAINING

- The TC and AA will provide the laboratory expertise for the conduct of undergraduate 4.1. (UG), postgraduate(PG) training work necessary to enhance skills.
- The AA will not have any financial liability towards the provision of 4.2. fellowship/scholarship to the students.
- The period of work and number of students per discipline shall be decided mutually by
- The Head of TC and the CEO of AA will settle any differences/policy issues arising out 4.4. of implementation of this agreement after mutual consultation. Their decision will be final.

RESPONSIBILITIES OF TC AND AA 5.

- 5.1. TC and AA shall ensure access to the facilities to be used for project activities to concern students without restrictions on time wherever necessary. 5.2.
- The access to the lab facilities wherever necessary may be facilitated by TEMPORARY ENTRY CARDS that can be used throughout the project period.
- 5.3. TC and AA shall undertake the work on the collaborative training as per schedule of work mutually agreed by the parties.
- 5.4. TC/AA shall provide all the basic facilities, to each other for fulfillment of the training under the agreement.

CONFIDENTIALITY 6.

Information as may be vital to the interest of the Institutes/Company, or security/defense of the country is not parted with any other party.

FINANCIAL AGREEMENT

As a general principle, funding for the exchange of such personnel shall be based on a reciprocal sharing of costs: Travelling,

- accommodation and students/faculties/engineers required for visit/meetings under this agreement will be daily borne by the respective institute/company as per the prevailing rules and regulations, if such meetings are not sponsored by third party funding agencies. 7.2

The TC and AA shall undertake / assist/ co- operate with each other to carry out trials/studies/activities as per the protocols drawn up.

- 10.2 The right and/or liabilities arising to any party to this agreement shall not be assigned except with the written consent of the party and subject to such terms and conditions as may be mutually agreed upon.
