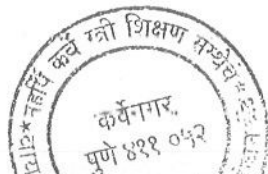

### AND

**Anekant Education Society's, Tuljaram Chaturchand College of Arts, Science and Commerce,(Autonomous) Baramati, Pune- 413102, the Second Party**, and represented herein by its Principal Dr. C. V. Murumkar (here in after referred to as "Second Party", company which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

(First Party and Second Party are here in after jointly referred to as 'Parties' and individually as 'Party')

### WHEREAS:

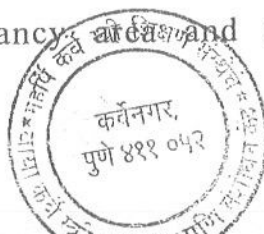
First Party is a Women's Study Center named: **Maharshi Karve Stri Shikshan Samstha's Baya Karve Women's Study & Research Center, Pune**

Second Party is a Higher Educational Institution named: **Anekant Education Society's Tuljaram Chaturchand College, Baramati. Tal: Baramati, Dist: Pune- 413102.**

First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

The First Party intent to perform professionally for Second Party. The consultancy fees or professional fees would be mutually agreed by both the Parties unanimously. The Parties will decide mutually to act upon the mentioned consultancy and departments, certificate courses for

students and staff, training modules, workshops or programmes for teaching, non-teaching staff and students here in MoU per calendar year. Both **The Parties** seek the cooperation from each other during performing the activities mentioned as below. Both parties focus their effort on the area of Strategic based upgrading present and future Human Resources both Teaching and Non-Teaching Staff, Students through workshop, certificate course, Debate and Discussions, Research on value education, gender sensitization and cyber security, upgrading the present skilled workforce, guiding Real case based research activities to meet the social needs, Supporting activities to develop the resources to built a firm foundation.

A. Both Parties, being legal entities in themselves desire to sign this MOU as Second Party would like to utilize the services offered by First Party and advance their mutual interest.

**NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:**

#### **CLAUSE 1 CO-OPERATION**

1.1 Both **Parties** are united by common interests and objectives, and they shall establish channels of communication and cooperation that will promote and advance their respective operations within the college and its related wings. **The Parties** shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for college development.

1.2 The general terms of co-operation shall be governed by this MOU. The **Parties** shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the **Parties**. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the **Parties** on the subject matter hereof.

## CLAUSE 2 SCOPE OF THE MoU

- 2.1. Start Gender Cell at Tuljaram Chaturchand College of Arts, Science and Commerce College (Autonomous), Baramati, Dist: Pune Pin- 413102
- 2.2. Exchange of student/ staff for need-based activity including Research, Education & Extension
- 2.3. The collaboration may involve the exchange of faculties and students for a short duration for knowledge sharing.
- 2.4. Provide the infrastructure facilities like Laboratories, Processing Units, Conference Halls, and other infrastructures/ demonstration units.
- 2.5. To organize collaborative activities like workshops, conferences, seminar, orientation/refresher courses and related activities.
- 2.6. To carry out activities of common interest suitable for both agencies.

### 2.7. Financial Consideration:

Micro planning and the details will be decided with mutual consent as per requirement also the financial details will be finalize for various events with the mutual consent from both the parties after the approval of specific activity. Once the **Second Party** deals the financial consideration, then **First Party** will take-up consultancy services, workshops, counseling, mentoring, or training programmes mentioned in the MoU or needful training programmes, consultancy services, workshops, counseling, and mentoring would be render as per the market demands by the **First Party**.

### 2.8. Consultancy or Professional Services Payment Terms:

**Second Party** will pay mutually agreed fees to **First Party** within the seven days of working period after every service or services render to **Second Party** through trainings, workshops, counseling, and mentoring. Such consultancy or professional services fees will be paid by **Second Party** through Cheque or NEFT/RTGS to **First Party** in favor of Baya Karve Women's Study and Research Centre Pune


## CLAUSE 3 INTELLECTUAL PROPERTY

- 3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppels or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copyrights and designs) of the other Party.

## CLAUSE 4 VALIDITY







This Memorandum of Understanding shall remain in for five years from the date of signing and be subject to revision or modification by mutual consent. Both parties shall discuss and decide on the continuation or revision of Memorandum six months prior to its expiration.

- This MOU is not intended to be a legally binding document it is meant to describe the nature of and to suggest the guidelines for the cooperation described above. Nothing therefore shall diminish the full autonomy of either institution, nor will any constraints be imposed by either upon the other in carrying out this MOU.
- This MOU shall be effective when appropriate representatives of first and second party affix this signatures below.

#### CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that **First Party** and **Second Party** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations, or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party. **First Party** **Second Party** Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at the District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of Baramati.
