Savitribai Phule Pune University (Received Best College as well as Best Principal Award 2017) and also working on rural development through different programs. It has established a strong line of research through Department of Bio-Technology (DBT), Department of Science & Technology (DST), University Grant Commission (UGC), Government of India and Indian Council of Agricultural Research, (ICAR), New Delhi and different Universities. The institute is recipient of funds from almost all the prominent research agencies in India. It has received DST FIST 'O' Level, Star College and College with Potential for Excellence (CPE). #### A. Purpose & Objectives:

The purpose of this MoU is to create a framework for collaboration between **USTM** and **TC COLLEGE** with the objectives as given below:

- To establish close linkage and functional coordination between USTM and TC COLLEGE.
- b) TC COLLEGE will collaborate in different student activities and developmental programmes of the university from time to time.
- c) USTM and TC COLLEGE will jointly organize Seminars, Workshops, Conferences, Symposiums & Competitions from time to time.
- d) USTM will offer freeship / scholarship for poor meritorious students for higher education on recommendation from TC COLLEGE authority.
- e) USTM and TC COLLEGE will jointly undertake Research & Project works in emerging areas with local relevance by the students/ scholars and faculty members of the University.
- f) TC COLLEGE and USTM shall facilitate the students for Internship programs/ project works/exposure trips/placement from time to time.
- g) Apart from the aforesaid linkage USTM and TC COLLEGE shall collaborate to organize extension and outreach activities like socio economic & welfare initiatives for neighboring & rural communities.
- h) USTM and TC COLLEGE will jointly organize awareness campaigns, rallies, street plays etc., celebrate important occasions and appreciate good works by offering felicitation to the performers from time to time.
- USTM and TC COLLEGE will extend support to the people in distress during any natural calamity of the region.
- USTM will provide professional support to TC COLLEGE.
- k) USTM and TC COLLEGE will also work in any other areas of common interest.

### B. Modifications to the Memorandum of Understanding

The MOU can be modified through mutual written consent of all the parties to this MOU. Any terms and conditions which are not the part of this MoU, will be decided with mutual consent.

#### C. Termination

This Memorandum of Understanding may be terminated by either party with a minimum of Thirty (30) days written notice. Activities in progress at the time of termination of this

Memorandum of Understanding shall be permitted to conclude as planned unless otherwise agreed.

#### D. Dispute Resolution:

a. Any dispute occurring under the MoU shall be settled amicably through consultation between the two parties.

b. Any issue which cannot be resolved within the general terms of MoU will sought to be resolved through Arbitration Proceeding involving the parties concern.

c. In case any issue(s) demanding resolution beyond mutual settlement will be subject to local jurisdiction of the judicial proceeding within the State of Meghalaya (District- Ri Bhoi), India.

This MoU is valid for 3 years from the date of signing of the MoU and can be extended for another period of 3 years on the recommendation of a review committee. The MoU will automatically lapse after 3 years unless renewed.
