Each party Here here shall act as an Independence entity and neither shall act as an agent of either organization for other purpose neither party has the authority to bind the other party.

5. Non- exclusivity

The agreement reflected by the provision of this M0U is non exclusive in nature and both the parties can enter into Cooperative arrangement with other parties to suit their organizational needs.

6. Confidentiality

The parties understand that in the course of their association, they shall have access to confidential information provided by the other party accordingly the parties agree that such information which is by its nature, not confidential or which is in the public domain or which the party comes to know about other than through violation of any law of legal obligation, provided that such party may be entitled to disclose such information it legally required to be disclosure to a competent authority. Failure to maintain confidentiality shall entitle the effect party to terminate the MoU.

7. Validity

The MoU would remain valid for a period of 5 years from the date it is signed by the parties and is renewable on mutual constant for such further period as agreed upon.

8. Terms and Review

The MoU shall be reviewed at the end of one year from the date of signing of this MoU. Either Party Can terminate the MoU after giving one month's notice to the other party subject to fulfillment of commitments already agreed upon.

9. Amendments

This MoU constitutes the entire understanding between the parties hereto. Except as otherwise provided herein, no edition, amendment to or modification of this MoU shall be affected unless it is in writing and signed by and on behalf both parties by their respective authorized signatories.


