
AND

ARTICLE 1

SCOPE OF THE MoU

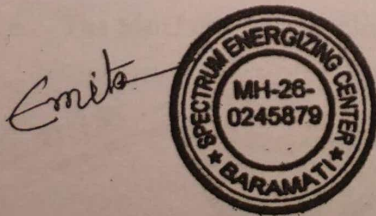

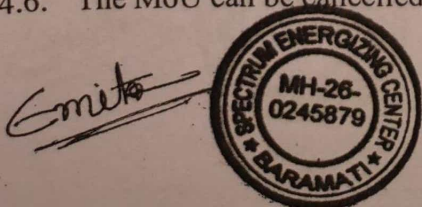
#### RESPONSIBILITIES OF TULJARAM CHATURCHAND COLLEGE, BARAMATI UNDER THE MoU

In case of any disputes or claims on any matter related to the project or during the course of its implementation, arising out of or in connection with the execution, interpretation, performance, or non-performance of this MoU or any or all of the foregoing, the decision of Principal, Tuljaram Chaturchand College, Baramati shall be final and binding.
- 4.5. This document is not intended to create any legal relation or constitute a legally binding contractual agreement between the parties and nothing in this MoU is intended to impose any legal relationship, rights, duties, sanctions or liability on any party for the purposes of litigation before any court of law.
- 4.6. The MoU can be cancelled or terminated by any side after giving one months' notice.

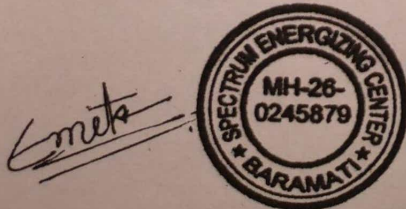



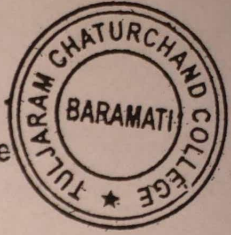
