3. To prepare and approve curriculum of S.Y.B. Com Semester-III (2022 pattern) Skill Enhancement Course (SEC) syllabus to be implemented from the academic year 2023-2024.

As per the 2022 pattern credit structure it was decided by the college academic council that from 2023-24 in 2022 pattern syllabus skill enhancement courses (SEC) practical subject must be introduced and implemented. Dr. Bale showed the syllabus of practical subjects and shared the guidelines regarding how to implement this practical subject. After the discussion CMA Dhavalikar made a valuable suggestion to include practical aspects of Cost Sheet, Cost Classification and Material Documentation.
