

TO PROMOTE QUALITY IN HIGHER EDUCATION

1) Introduction:

One of the greatest challenges to India's growth trajectory for the next century is the quality of education imparted to the next generation by our Higher Education Institutions. University Grants Commission has dedicated itself to the pursuit of excellence with a specific focus on quality as enshrined in the UGC "Quality Mandate". After due deliberation and consultation, the UGC has approved the objectives set for improving the overall quality of Higher Education Institutions.

The Paramarsh **scheme** is expected to have a major impact in addressing a national challenge of improving the quality of Higher Education in India. This will target 1000 Higher Education Institutions for mentoring with a specific focus on quality as enumerated in the UGC Quality Mandate.

2) Objectives:

- To enhance the overall quality of the Mentee institutions and mentoring the Non-Accredited Higher Education Institutions to enable them to get accredited.
- The Scheme will operate through the IQACof TuljaramChaturchand College of Arts, Science and Commerce and IQAC of the mentoring colleges.
- Hub can also be conceived as a pool of experts from multiple resources. External members can also be solicited from the industry and can he used as a resource pool. They can make a ground assessment and can have a clear action plan for mentoring.
- Tuljaram Chaturchand College of Baramati has taken initiative of bringing colleges together for the purpose of cooperation, promotion and networking of IQAC's of respective colleges to standardize policies, procedures and collectively work out the areas for better academics and administration.

3) Mentoring colleges shall facilitate the following:

- Training of faculty and staff for proper documentation and presentation.
- Sharing of knowledge, information and resources.
- Opportunities for research collaborations and faculty development.
- Guidance and encouragement to adopt best practices
- Counselling to thr management

Details of mentoring areas:

- To create a platform for working together.
- To share thoughts, ideas and solutions on problems faced by the educational institutions.

- To develop academic and administrative procedures and methodologies that are unand logically acceptable.
- To promote teachers for working together in academics, co-curricular and extra curricular activities.
- To share libraries and laboratories
- To focus on the end user 'The Student'
- To create a platform to sort out issues between organizations who share similar geographical location or have similar courses etc.
- To screen the areas among social, administration, teaching learning process, research etc.
- 4) Duration of MoU: Duration of the MoU shall be of one year which can be extended up to two years.

5) Purpose:

The parties enter into this MoU for the primary of Cooperation, Promotion and Networking of IQAC's of respective colleges to standardize, policies, procedures and to collectively work out areas for better academics and administration and to bring a qualitative change in organizations with IQAC.

6) Authority:

This MoU is made between IQAC of Tuljaram Chaturchand College, Baramati and institutions listed below, referred as 'the parties' to this MoU.

This MoU will primarily be governed by the respective principals of the colleges in their campuses. The IQAC coordinator / nominees will be the authority to represent the colleges. The collective decisions will be implemented by the IQAC coordinators through mutual consent and coordination.

- Guidance and encouragement to institutions to adopt best practices.

ii. Mentees Role, Reponsibilities and Benefites:

- To have necessary agreements for conducting activities in the colleges.
- To share information confidentialy that could not harm the participating organizations.
- To create better working environments and better academic practices through joint activities.
- To create easy and better documentation procedures
- To promote IQAC assessments in the college and provide genuine inputs
- To create variety of feedback mechanisms.
- To prepare the IQAC calendar of events for better governance.
- To promote core values of NAAC.
- Any other activites of common interest that promote quality education.
- Brings about enhancement in the overall quality of the mentee institute.
- Enhances the profile of institution as a result of improved quality of research, teaching and learning methodolities.
- Receives support in the professional development of academics.
- Increased exposure and speedier adaptation to best practices.
- Advantage point in NAAC accreditation

8) Agreeements:

In order to foster successful completion of this MoU, the parties shall agree to the following terms and conditions.

- Each college pledge will good faith and go forward with this MoU and achive the goals and purposes to this MoU as per the terms and conditions of this MoU. The parties shall resolve disputes through mutual understanding.
 - By mutual agreement, which may be either formal or informal, the parties may modify the list of intended activities set or decide the practical manner by which the goals, purposes and activities of this MoU will be accomplished. However, any modification to any other written part of this MoU must be made in writing and signed by either the parties or their representatives.
- Central Government, State Government, UGC or university laws shall be mandatory for all.
- The parties will not compel each other that could lead to any legal hassle.
- The issues with intellectual property right can be shared only with prior permission of the concerened parties.

The parties hereby agree to the said MoU, which shall be effective from 04th Oct. 2019 for two years.
